IN ITS ENTIRETY, SOUND HEALING TULUM,
FACILITATORS AND STAFF AND ALL ITS AFFILIATES,
MANAGERS, MEMBERS, AGENTS, ATTORNEYS,
VOLUNTEERS, HEIRS, REPRESENTATIVES,
PREDECESSORS, SUCCESSORS AND ASSIGNS,
FROM ANY AND ALL CLAIMS OR CAUSES OF
ACTION AND I AGREE TO VOLUNTARILY GIVE

UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST MITCH MOORE, JOEY MCCUNE, CASA SELVA, THE PROPERTY, CENOTE SAGRADO, SOUND HEALING TULUM, ANY AND ALL FACILITATORS, STAFF AND AFOREMENTIONED, FOR PERSONAL INJURY OR PROPERTY DAMAGE. I ACKNOWLEDGE THAT I MAY CHOOSE TO PARTAKE/PARTICIPATE IN PLANT MEDICINE AND THAT IS MY PERSONAL CHOICE AND I RELEASE LIABILITY FOR THIS ACTION AND ANY OUTCOME, I ACKNOWLEDGE THAT I AM RESPONSIBLE FOR MY OWN DOSAGE AND **OBTAINING ANY ILLEGAL SUBSTANCES WITH FULL** RELEASE OF LIABILITY TO AFOREMENTIONED PARTIES. I ACKNOWLEDGE THE LOCATION IS IN THE JUNGLE AND THAT AN UNFORESEEN ACCIDENT CAN OCCUR WITH POISONOUS PLANTS, INSECTS, PARASITES, BATS, SNAKES AND OTHER WILDLIFE. I RELEASE LIABILITY FOR ANY AND ALL ACCIDENTS FORESEEN AND UNFORESEEN, INCLUDING BUT NOT LIMITED TO, FALLING, SWIMMING, DROWNING, PLANT MEDICINE, DISEASE, INFECTION, OR DEATH.

I AM OF SOUND MIND AND BODY WHEN SIGNING THIS "WAIVER AND RELEASE".

To the extent that statute or case law does not prohibit releases for ordinary negligence, this release is also for such negligence on the part of Mitch Moore, Joey McCune, Sound Healing Tulum, Casa Selva, the property, its agents, facilitators, staff and employees.

I agree that this Release shall be governed for all purposes by law, without regard to any conflict



of law principles. This Release supersedes any and all previous oral or written promises or other agreements.

In the event that any damage to equipment or facilities occurs as a result of my or my family's or my agent's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any such actions of neglect or recklessness.

THIS WAIVER AND RELEASE OF LIABILITY SHALL REMAIN IN EFFECT FOR THE DURATION OF MY VISIT OR PARTICIPATION IN THE ACTIVITY, CEREMONY OR EXPERIENCE, DURING THIS INITIAL AND ALL SUBSEQUENT EVENTS OF PARTICIPATION.

I agree that safety is primarily dependent upon taking proper care of myself during my visit/retreat/ ceremony/workshop, and I am following any and all pre and post ceremony/retreat, dietary and health guidelines suggested. I have consulted my personal health care provider prior to starting any new healing activity/program to insure personal health safety.

The act of signing this form is representation that I understand participation as a guest visiting the property, and as a participant in any ceremony, retreat or experience offered, may present a risk of injury or harm to myself, and I agree that this risk is fully born by myself, the participant. As a guest or participant, I take full responsibility for any accidents seen or unforeseen that may occur.

This includes, but is not limited to, claims involving economic loss, illness or mental or medical condition, injury or accidental death.

I acknowledge having read and understood this Release of Liability. I, the guest or participant, agree with this Release of Liability and precisely express full understanding of this document and signed WAIVER AND RELEASE OF LIABILITY.

I understand that there exists a risk of physical, mental, psychological, or emotional injury or death from the Activities and although personal discipline or compliance with the guidance of facilitators or staff may reduce this risk, the risk of such injury nevertheless does exist.

I am fully aware that the activities could be hazardous, resulting in injury or death. I fully acknowledge that I am voluntarily participating in the activities with knowledge of the danger involved, and I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation.

I agree to comply with the stated and customary guidance and norms of participation in the activities. If, however, I observe any unusual hazard during my presence or participation, I will immediately remove myself from participation, in the activities and bring attention of the nearest official forthwith.

I know, understand, and acknowledge that the owners, facilitators, staff and Releasees are not physicians, psychologists, or healthcare professionals, and the activities being offered are not intended to treat or diagnose and do not include treatment for, or diagnosis of, any illness, disease or disorders, whether physical, mental, psychological or emotional.

I promise, represent, and certify that I am physically, mentally, psychologically, and emotionally in good health. I fully understand and acknowledge that I would not be permitted to partake in the activities if I were not in such good health. As such, my promise, representation, and certification that I am in good health in each of the above-enumerated ways constitute a material term upon which the owners and Releasees are relying on, permitting me to partake in the activities.

If I am pregnant or become pregnant, or am postnatal, I will not participate in the activities without first discussing the risks with my doctor. I will only participate in the activities if I have my doctors full approval. I will not held the released parties responsible for any injuries to my pregnancy caused in part or in whole by my failure to follow my doctor's recommendation.

I hereby forever, unconditionally, and irrevocably waive and release any and all claims I now have or may have in the future against the Releasees with respect to any injury, loss, or damage I suffer as a result in the activities or any of the future activities in which I may participate.
